The Hunt Brothers® Pizza Facebook Giveaway (the "Giveaway") is sponsored by Hunt Brothers Pizza, 4020 Jordon Station Road, Nashville, TN 37218 ("Hunt Brothers Pizza" or "Sponsor"), and is open only to legal residents of the United States who are at least eighteen (18) years of age at the time of entry. Corporate entities are not eligible and have no right to claim any prize won by their employees. Employees, officers, directors of Sponsor and its advertising, promotion and public relations agencies (all such individuals and entities collectively referred to herein as the "Giveaway Entities") and the family members (residing in the same household of each) are not eligible to enter the Giveaway or win a prize. For the purposes of this Giveaway, family members are defined as spouse, partner, mother, father, legal

guardian, in-laws, grandmother, grandfather, brother, sister, children and grandchildren (including “step” as they may apply).

2. The competition will run for **twenty-four (24) hours from the time the giveaway is posted on Facebook (“giveaway period”).**

3. There is one way to enter the competition:

Entrants must comment on the giveaway post on Facebook (Facebook.com/HuntBrothersPizza). In order to enter the competition, comments that meet the requirements must be sent between the competition period. **Each Facebook account is eligible to win one (1) prize. Limit one (1) entry per person per account.** Any offensive, obscene, defamatory, profane or otherwise inappropriate messages as determined by Hunt Brothers Pizza will not be entered into the competition. If you do not have a Facebook account, visit www.Facebook.com and register in accordance with the enrollment instructions for a free Facebook account. Entrants must comply with the Facebook Terms of Service and Facebook Rules available at www.Facebook.com.

4. Each entry must be original to the entrant and must not violate any third party rights or violate any law, statute, ordinance or regulation.

5. Sponsor shall select winners by random drawing from all eligible Entries received during the Giveaway Period. The drawing will be conducted by a sponsor designee, whose decisions regarding the random drawing will be final. Winners will be selected within three to five (3-5) days of the giveaway being posted.

6. Prize item and quantity are at the jurisdiction of the sponsor. All taxes related to a prize are payable by the winner. The prizes are non-transferable and no cash alternatives will be provided. Hunt Brothers Pizza reserves the right to substitute the prizes described above with prizes of equal or greater value.

7. The potential Winner will be notified that he/she may have won a prize by a Hunt Brothers Pizza comment directly on the giveaway post and in a direct message (an “Unofficial Winner Notification”). The comment will direct the winner to send his/her mailing address and birth date in a direct private message. Sponsor or a Sponsor designee will then ship prize.

8. If a selected participant cannot be reached within five days of receiving the winner notification, or otherwise does not meet all competition conditions, his/her prize will be forfeited.

To be declared a winner, the selected entrant will be required to send Hunt Brothers Pizza a direct message through Facebook confirming acceptance of the prize was awarded and releasing Hunt Brothers Pizza and their affiliates from any liability relating to the prize. By entering this competition, entrants consent to the
